#### 5. Reports

## a. Board Report, Donna Hobbs - Chair

Donna noted that the Annual Report is posted on the BBBSV website. Highlights:

- Over the past year, BBBSV has continued to experience high demand for mentoring services from children and youth in our community. 489 kids were served through our mentoring programs
- We are celebrating our 45<sup>th</sup> year of serving our community from 1977-2022 The Board marked this milestone with a new strategic plan with the goal to serve 1000 children by 2025
- Our vision: all young people reach their full potential. Mentoring relationships are proven to reduce the impact of adversities and support youth to grow and thrive. When we match a young person with a trusted adult mentor, we start something incredible - a life-changing relationship with the needs of the child at its core

Donna introduced and welcomed Sue Pratt. Sue has stepped in as our interim Executive Director for the next couple of months

# **b.** Executive Director Report, Sue Pratt – Interim Executive Director Highlights:

- 2021/2022 continued to be a year of change as COVID was still with us
- Under the excellent leadership of Rhonda Brown, Executive Director, and the Board the organization has thrived
- Staff have really stepped up during challenging times navigating inability to enter schools, being unable to meet in person, finding new ways to divert donations from the landfill
- Everyone in the organization has had to pivot over the last year staff, volunteers, parents and guardians, and even donors
- We have over 127 children on the waitlist. The waitlist confirms our Vision 1000 and highlights the need to grow our organization to serve 1000 children or more
- We could not do it without you our members, our staff, our donors, and the
  great community that supports us in so many ways. Thank you! And thank you
  to the Board and committees for their continued good work

# c. Audited Financial Statement Report, Agnes Piotrowski – Treasurer Highlights:

In this challenging fiscal environment BBBS ended the fiscal year with a
deficiency of revenue over expenses of \$11,685. This deficiency was due
primarily from significant decreases in the government's COVID assistance
programs, and the challenging market for retaining and attracting resources

- Revenue in 2022 increased by 6% over prior year at \$1,385,752 (due primarily from a successful year for Social Enterprise and Grants and subsidies)
- Overall expenses increased by 17% to \$1,422,574 as the organization experienced increased building occupancy costs, truck operating and rental costs, and wages - impacts of unprecedented inflation
- In 2021 the Board created a Vision 1000 reserve fund of \$280,000 to be used over three-years (July 1, 2021 to June 30, 2024) to fund initiatives to grow the organization to serve 1000 young people. This year \$22,413 was expended on Vision 1000 initiatives

Motion by Agnes Piotrowski to adopt the 2021/2022 Audited Financial Statements; seconded by Mike Wyeth; motion carried.

# d. Appointment of auditors

Motion by Agnes Piotrowski to appoint KPMG LLP to perform an audit for the 2022-2023 financial year ending June 30, 2023; seconded by Meghan Casault; motion carried.

**6. Election of the Board of Directors** – Mike Wyeth reported that five (5) current Board Members are returning for the second year of their term; four (4) Board Members are standing for reelection
