

Make a lasting difference with a legacy gift.

Creating a legacy gift enables you to make a lasting difference while retaining full use of your assets during your lifetime. A legacy gift with **Big Brothers Big Sisters of Victoria Capital Region (BBBSV) Charitable No. 106793540 RR0001** also provides significant tax advantages that benefit your family and heirs after your death. A bequest is tax-effective – your estate may claim gifts in the year of death equal to 100 per cent of your net income in that year and unused credits may be carried back one year.

A bequest is revocable (cancelled) and can be changed if your financial circumstances change.

There are different types of legacy gifts, also known as bequests or estate gifts. Your will must clearly indicate the recipient of your gift, to successfully carry out your wishes.

General bequests are a legacy left to **BBBSV** that comes from the general value of the estate, and are made by designating a specific dollar amount, a particular asset or a fixed percentage of your estate to BBBS.

Specific Bequests are made when a particular item or property is bequeathed for a designated purpose. (i.e., _______ bequeathed to BBBSV for its use; funds to be used in the operation of a particular program.)

You can create a meaningful legacy by designating your gift to BBBS and, if you wish, to a priority area that matches your interests with BBBSV's future plans.

Residual Bequests are made when you intend to leave the residue portion (any leftover property) of your assets to **BBBSV** after other terms of the will have been satisfied.

Contingency Bequests allow you to leave a portion of your estate to **BBBSV** if your named beneficiary does not survive you.

- ✓ Upon your death, **BBBSV** will receive your gift and put it to work to support the BBBS priorities you specified in your fund agreement.
- ✓ A receipt for tax purposes will be issued to your estate for the <u>full fair-market value of your gift</u> based on rules outlined in the Canada Income Tax Act.

Three ways to give:

By naming BBBS in your will as follows: **Big Brothers Big Sisters of Victoria Capital Region** (Charitable No. 106793540 RR0001)

Direct your gift through your local community foundation for the benefit of **BBBS**. BBBS has an endowment fund with **Victoria Foundation** and **the Vancouver Foundation** that has been established in perpetuity with interest income directed to the work of BBBS.

Alternatively, you can establish your own endowed fund for the benefit of **Big Brothers Big Sisters of Victoria Capital Region**.
