Donna Hobbs, President of the Board, welcomed everyone to the AGM and thanked attendees for accommodating a hybrid meeting – in person and online. Donna delivered a territory, diversity, equity, and inclusion acknowledgement.

Donna welcomed guest speaker Samreet Gill, from our National Youth Mentoring Advisory Council of Big Brothers Big Sisters of Canada.

Donna expressed her thanks to the Big Brothers Big Sisters of Victoria community - staff, volunteers, sponsors, donors, board members and supporters – for their support in our mission to enable life-changing mentoring relationships to ignite the power & potential of young people.

Donna introduced Board members, and acknowledged and thanked staff for attending the meeting.

- 1. Quorum was confirmed by Karen Mark, Secretary. Donna called the meeting to order at 6:18 pm.
- 2. Adoption of Rules of Order Donna announced that Robert's Rules of Order shall govern all meetings of the Society and tonight's Annual General Meeting in accordance with the Bylaws. Donna gave an overview of how the hybrid meeting will be managed, e.g. those attending by Teams will vote by using the chat function to approve, oppose, or abstain.

## 5. Reports

## a. Board Report, Donna Hobbs - Chair

Donna invited everyone to read the 2022-2023 Annual Report available on the BBBSV website and shared some highlights from the 2022-2023 fiscal year.

Long-time Executive Director Rhonda Brown passed away in July of this year. Rhonda was a lifelong champion for kids. Her care and compassion were felt deeply by every person she interacted with, especially over 3,3000 children who were mentored during her 16 year legacy at BBBSV.

# b. Audited Financial Statement Report, Agnes Piotrowski – Treasurer

BBBSV proved its resiliency and dedication with financial prudence, innovation, and a dedicated team that lead to brilliant achievements in a year of uncertainty with ripple effects of the economic impact of the pandemic.

In 2021 the Board created a Vision 1000 reserve fund of \$280,000 to be used over three-years to fund initiatives to grow the organization to serve 1000 young people. In current year \$102k was expended on Vision 1000 initiatives.

# 7. Executive Director report – Amanda Hill

Amanda joined BBBSV in March under difficult circumstances and with uncertainty ahead. Learnings include:

- We currently have a team of 26 staff, we add some with Co-op students and the total goes up and down with the seasons. I've learned that our staff are resilient and adaptable
- BBBSV has been operating in Victoria for 49 years (big 50 next year!) and Amanda has met many people in the community that have mentioned a connection with Big Brothers Big Sisters, and they speak so positively about the good feelings of mentorship they had
- Staff go out of their way to help connect a youth in need of a doll house, a bike, coats, back packs, tickets, salmon fishing or sharing new skills in a welcoming group, all encompassed around mentoring
- We have board members who are also mentors and have long standing volunteer contributions to our agency. Our appreciation and gratitude to outgoing board members this year- Silvia, Megan and Kaylee
- Amanda has met many donors and sponsors who appreciate the impact mentoring has in their workplaces and companies as these youth become the employees and leaders of the future
- Single biggest thing Amanda has learned in 7 months with BBBSV? That impact is hard to measure, the numbers do give you some perspective. What we can't measure are the intangibles and those are because of the people. The staff, the volunteers, the mentors, the mentees, the families, the school staff and all our donors and supporters. It is the people who make a difference and the relationships they make are what gives us the greatest impact
